

# TERMS AND CONDITIONS FOR COMPETITIONS

## 1. ORGANIZER

The raffle and the competition are organized by the Union of Professional Engineers in Finland, Ratavartijankatu 2, 00520 Helsinki. (later in this text, "Organizer").

## 2. ELIGIBILITY

All adult real persons can participate in the raffle and competition. Employees of companies and their family members who have been involved in the arrangements for this lottery are not eligible to participate. By participating in this raffle, entrants agree to abide by these terms and conditions rules.

## 3. DURATION OF PARTICIPATION

The time of participation is specified on the lottery and competition pages. The organizer reserves the right to change the schedule of the lottery or competition for a justified reason. If the draw or competition is terminated prematurely, the prizes will be drawn among the participants in the draw by the time of the suspension.

## 4. PARTICIPATION IN THE DRAWING

All participants defined in point 2 who have acted as requested on the lottery page by 23:59 on the day of the lottery will participate in the draw and competition.

## 5. PRIZE

Prizes to be drawn with their values are announced on the lottery pages. The winner will be notified of the prize by email and the prize will be mailed to the address provided by the winner within approximately two weeks of the draw date.

The names of the winners can be published in the publication channels of the Union of Professional Engineers in Finland.

The prize is personal, non-resellable, non-cash and non-refundable. The winner of the prize releases the organizer of the lottery from all liability in connection with the receipt or use of the prize. The winner is responsible for purchasing all products and services required to use the prize. The total responsibility of the lottery organizer for each lottery participant does not exceed the total value of the prizes mentioned in these rules. However, these limitations of liability do not limit the consumer's rights under the Consumer Protection Act. The raffle organizer pays the lottery tax on the prize.

The organizer of the draw and competition is not responsible for any changes to the prize caused by reasons beyond its control. The Organizer has the right to change the prizes it has announced to replacement prizes that have the same value as the previously announced prizes.

## 6. RESPONSIBILITY FOR TECHNICAL PROBLEMS

The Organizer is not responsible for the operation of the lottery participation channels or for participations that are interrupted or lost due to technical problems.

## 7. INFRINGEMENTS

If there is reason to suspect a participant in the lottery of fraud or participation in the lottery other than in the manner specified in the rules, the Organizer has the right to refuse participation.

## 8. PROCESSING AND COMMUNICATION OF PERSONAL DATA

## 9. OTHER TERMS
