Your membership fee discount is calendar month-specific. You are eligible for the discount, which can be granted for full calendar months in 2022, if you do not receive any salary or entrepreneurial income or comparable income, have a very low income, live abroad, or study full time. You are not entitled to a discount over the averaging period of any severance package.

You can submit your application as soon as you are able to ascertain the beginning/validity of the grounds for discount. The discount is granted for the full calendar months of the eligible period of discount or, if the date of the termination of your eligibility is not known, for a default period of six full calendar months, extending no later than 31 December 2022. After we have examined the matter, we will issue a discount decision and possibly a corrected membership fee invoice. We will process the matter if you have paid your membership fees through 31 December 2021.
